I object to the process of notification and handling of objections by the public to the proposed treatment of Horsforth in Leeds site allocation plans.

The meeting held at Horsforth Library recently was difficult, the ballroom was overcrowded, information was hard to obtain and I had to wait for half an hour to speak to an official about traffic issues, as I have MS this was painful.

What is so exceptional that you need to build on Green Belt land this has not been explained to us. How will we be protected from foul air with so much extra traffic passing through our town and what is to be done about particle pollution and the lung damage our citizens will sustain, nothing has been mentioned.
