Dear Sirs

As residents of Cliffe Drive, Rawdon, we are very concerned at the proposed housing developments that Leeds Council are approving, leading to the loss of green belt.

It is obvious that should most of these applications be approved, the Leeds, Horsforth and Rawdon areas will be merged into one leading to the loss of green belt and its amenities.

Housing developments and the loss of green belt on this scale are contrary to the national planning policy, which states that green belt should be preserved thus preventing urban sprawl which is going to be the case between Leeds and Rawdon.

Not only would there be a loss of green belt, but the development takes place on land which is subject to conservation and preservation. If Leeds Council were allowed to grant development for these areas, most of the heritage and amenities of this unique area would disappear.

Additionally, we do not believe that the infrastructure of the area will be able to support development on the scale planned.

Whilst we appreciate the need for additional housing, there are many brown field sites which could be used for development instead of this wholesale eroding of the green belt

We cannot stress enough our objection to Leeds Council's attitude in destroying the green belt and hence beauty of the area.
