- > of LCC's 'Strategic Green Infrastructure'. Where would we
- > walk when it was gone?
- > Wild-life habitats around ancient Ghyll Beck would be lost,
- > despite HG2-12, HG3-3 and HG3-4 being part of UK
- > Biodiversity Action Plan. Bluebell woods and mature woodland
- > would go forever, along with several farms at Rawdon major
- > employers in the village. HG2-12, HG3-2 and HG2-41 are

> Overlooked Alternatives:

- > Brownfield sites, which LCC says must be developed before
- > greenbelt. Also, the council has ignored corrections in the
- > housing target which has been calculated at 45,000, not
- > 70,000 as formerly. this adjustment removes the need to
- > build on greenbelt.

- > Limited Highways Access:
- > Only one access point via Southlands Ave for HG2-12. Other
- > roads inadequate for 130 extra houses. Knotts Lane, even if
- > realigned for HG2-12, HG3-2 and HG3-3, would not solve
- > access issues onto A65. Also flooding at HG2-12 may make
- > site undeliverable.

- > Not Legally Compliant:
- > No prior consultation over HG2-12.

>

- > Not Positively Prepared:
- > Plans not based on comprehensive review but a selective one,
- > making site allocations unsound. Neither is it in accordance
- > with NPPF, esp: Protecting Greenbelt (Ch9), and Consulting
- > over Environment (Ch 11). In order to ignore these guidlines
- > the council has used 'growth' as an exceptional
- > circumstance, refusing to acknowledge their flawed
- > calculations.
