I have lived in Aireborough from birth so that is now 45 years. We have already seen a number of major housing developments going up in the area which has had impacts on the communities of Aireborough.

If we all sat back and did nothing while Leeds City Council passed plans for yet more housing, then I fear the area would become over developed. The proposals that you have put forward for housing on our Green spaces will spoil everything that we have come to love about Aireborough. They are **not justified** as they do not meet the needs of our community.

The current infrastructure falls short of meeting the current needs of the area so I just cannot imagine the impact if these plans were to go ahead. It would be **absolutely devastating!** We are already seeing impacts on;

Schools – Primary and Secondary schools at full capacity

Doctors and dentists – also at full capacity

Transport – this is a major concern, we already have what I call 'Gridlock Guiseley' not to mention high emissions by queuing traffic on our roads

**Employment** – if we lose our local rural economy and traditional farming, with no proposals for new businesses then where do people gain employment **Wildlife** – as green spaces shrink this causes an impact on our wildlife

Being able to get out into the local countryside to enjoy the green spaces and fresh air that we have on our doorstep is of great importance to us and everyone who lives in and visits the area. Being active is also an important part of a healthy lifestyle.
