

## **Points of objection to the proposed Gypsy/Traveller site (site ref: HG7-3)**

### **Ecology/Landscape**

- The site has a newly planted wood (provided by LCC in conjunction with the Woodland Trust) which has become a haven for wildlife and this will be destroyed
- The traveller way of life encourages the keeping of horses which will have an impact on grass verges and green spaces

### **Conservation/Heritage**

- Loss of Grims Ditch/Grims Dyke plus the wildlife it supports

### **Highways/Transport**

- Both Colton Lane and Bullerthorpe Lane are “fatal” roads. Bullerthorpe lane is particularly known by local people as an “accident Highway”. It is a 60mph road which suffers from subsidence which creates issues around poor visibility especially at night as it is without lighting. To have slow moving caravans and large vehicles pulling onto such a road is hazardous to say the least
- Without the removal of yet more trees the junction to pull out of the proposed site is blind, yet again potential accidents on an already notorious road
- Traffic congestion is already appalling at peak times trying to leave the estate via the only viable exits which are Style Hill Way and Colton Roundabout (school lane has major parking issues at these times therefore not a viable exit) can often take over half an hour
- The site is a public right of way which is a footpath, cycle path and bridle path for access to Templenewsam Park, Park Road and Meynell Road.
- Bullerthorpe Lane has no public footpath

### **Other – Health and Safety**

- The Traveller way of life encourages the keeping of horses which are often untethered or break free from being tethered. Given the proximity, poor visibility and the speed limit on Bullerthorpe Lane there is a potential for horses to wander onto the road and cause a major accident; not to mention the proximity of the motorway
- There are potential health and safety issues for local resident caused by the burning of plastic and cable and the impact of fires
- Materials of a potentially hazardous nature and the dumping of tree cuttings etc. will affect the public right of way

- There is only one GP Practice in the village with an approximate 2 week wait for an appointment
- There is only one school in the village which has 127 applicants for 30 places causing other local schools to also become over subscribed

- The proposed location is greenbelt land and I cannot see any exceptional circumstances shown in the SAP.
- Planning was refused on Bullerthorpe Lane for a wind turbine because the land was defined as greenbelt and it constituted an "inappropriate development in greenbelt"
